# TAXABLE PERSON AMENDMENTS ON THE EMARATAX PORTAL



## Introduction



### To whom does amendment apply?

• All taxable persons registered with the Federal Tax Authority for:

Excise Tax, Value Added Tax (VAT), Corporate Tax (CT)



### When is the amendment due?

• Within 20 business days of any of the relevant changes to its data maintained with the Federal Tax Authority



## Relevant Changes where an amendment is required

- Legal Entity Type
- Legal Name/Trade Name of the Company
- Trade License
- Ownership structure/documents
- MOA or AOA
- Business activities
- Addition/removal of branches and sole establishments
- Registered address and registered contact details (email ID and phone number) of the entity
- Emirates ID/Passport of Authorised Signatory, or any changes in the email ID/phone number of the Authorised Signatory
- Emirates ID/Passport of the Directors, Partners, Owners, etc.
- Other details including bank account details, import export details, etc.



### Impact of Non-Compliance

- For VAT and Excise Administrative penalty of AED 5,000 in the first instance and AED 10,000 in case of a repetition
- For CT Administrative penalty of AED 1,000 in the first instance and AED 5,000 in case of a repetition within 24 months from the date of violation



### Important to Note

The Emaratax portal does not allow to proceed with a new VAT/ CT registration (for a taxable person already registered for VAT/ CT) in cases where the taxable person's amendment is mandated by the FTA (for e.g., trade license/EID/Passport expired)
